ElectraLED, Inc. warrants that each Kubeluxx™ series product, when installed in compliance with ElectraLED installation instructions and review specifications, to be free from defects in material and workmanship and to operate from the date of purchase subject to the limited warranty time periods and the terms and conditions specified below.

If an ElectraLED Kubeluxx™ series product lighting system fails to operate during the limited warranty period, ElectraLED, Inc. will provide a free replacement component in accordance with the terms and conditions set forth below.

This limited warranty does not apply to any abnormal use or use in violation of any applicable standard code or instructions for use in installations including those contained in the latest National Electrical Code (NEC), the Standards for Safety of Underwriters Laboratory, Inc. (UL), Standards for the American National Standards Institute (ANSI) or, if in Canada, the Canadian Standards Association (CSA). This limited warranty does not apply to lightning strikes, power surges, or overvoltage conditions. This limited warranty will not apply in the event of conditions demonstrating abnormal use or stress, including, but not limited to, under/over voltage conditions, excessive switching cycles or operating hours. This limited warranty will not apply in the event of users mishandling of product which includes dropping. Replacement of ElectraLED Kubeluxx™ series products with LED components of other manufacturers will void the entire warranty. Modifications of any kind to the ElectraLED Kubeluxx™ series products will void the entire warranty.

After contacting ElectraLED, Inc., an RMA # will be issued so the purchaser can promptly return the ElectraLED product after receiving instructions regarding if, when and where to ship product. Failure to follow this procedure shall void this warranty. Note: This return policy is applicable solely to ElectraLED Kubeluxx™ series products. In the event ElectraLED ships out the replacement product on the RMA before ElectraLED has a chance to examine failed products to be returned, ElectraLED may require a purchase order until examination of failed product is completed.
